Half and half payments: \$1,930.62 x 2 times (15th and 30th)

*1st payment: You will receive an access code for the Theory.

*2nd payment: You will receive your student kits and access to start the practical.

2 month payment plan of \$1930.62/month = 4 payments of \$965.31 (15th \$965.31 and 30th \$965.31)

*1st, 2nd, and 3rd payments will be for Theory only. (The first 1.5 months will be the Theory only)

*From 4th payments: You will receive your student kits and access to start the practical.

4 month payment plan of \$965.32/month = 8 payments of \$482.66 (15th \$482.66 and 30th \$482.66)

*1st, 2nd, 3rd, 4th, and 5th payments will be for Theory only. (The first 2.5 months will be the Theory only)

*From the 5th payments, you will receive your student kits and access to start the practical.

6 month payment plan of 643.54/month = 12 payments of \$321.77 (15th \$321.77 and 30th \$321.77)

*Until 7th payments will be for Theory only (The first 3.5 months will be the Theory only)

*From the 8th payments, you will receive your student's kit and part of access to start practicing.

You will not receive a transcript or certificate until the financial obligation has been met.

The final payment must be in the form of cash or credit card. No personal checks will be accepted.

Disclaimer

Suppose the student has a second party who is responsible for payments. In that case, all the required information must be given to Administration with the number of incremental payments and the date payments are to be made, and the form of payment must be approved by the school's Director, Mr. Eric Ho.

Installment Payments/Balance

- Installments are due on the 15th and 30th of the month by 4 p.m. If the due date falls on a weekend or holiday, payments are due by 4 p.m. on the next business day. There is no grace period.
- You are responsible for making the payment each month. Payments will not automatically be made by the Students Admissions and Financial Services Office unless you complete the Credit Card Authorization Form.
- If you are mailing the payment, make sure you allow enough time to reach the office on or before the due date. Payments received after the due date will be assessed as a late fee.

Fees and Other Charges

- Your application fee is nonrefundable.
- Your account will be assessed a \$20 service charge for any payment returned for insufficient funds or which is not collectible for any other reason, and your plan will be canceled.
- There will be an additional late charge for any payment not received in full by the due date.
- If payment due is from \$0 – \$999.99, a \$20 late fee will be charged to your account.
- If payment due is from \$1,000 – \$1,999.99, a \$25 late fee will be charged to your account.
- If a payment due is \$2,000 or above, a \$30 late fee will be charged to your account.

Failure to Pay

- If payment is delayed, we will immediately suspend your online access.
- A late payment fee will be added, and the remaining account balance plus the late fee will be due in full.
